In 1990, a group of people with learning disabilities in Carlisle decided it was time to make a change. They said, "Enough is enough!" and were determined to shape local services for the better, so that everyone who walked through their doors would have their voices heard, and their rights respected. They wanted to create a better future for themselves and future generations. Together they established People First.

In 2012, we furthered our reach, providing advocacy to anyone who needed it, whether they were older adults, black and ethnic minority communities, or people with mental health needs. In 2018 we started working with in Lancashire, providing the same vital support to communities across the county. Then in 2023 we expanded to across the North East with our team of advocates working directly in the community to support people, through our advocacy service, in their darkest and hardest times.

In 2024 People First began working in partnership with The Well Communities- a lived experience recovery organisation (LERO). This partnership centers on supporting people to take control of their own lives and recovery, helping them to transform and build a stronger future.



People First is an amazing organisation which has grown and diversified in recent years.

We are lucky enough to have a team of amazing, outstanding staff that work tirelessly to deliver support and services all aimed at empowering lives. We work in communities across Cumbria, Lancashire and the North East.

### Who we are

People First Independent Advocacy is a registered charity (Registered charity number 1184112) and an independent customer-led organisation that has worked in the North of England for over 35 years, with the mission to help people live informed, respected, healthy and fulfilled lives. We have a deep understanding of the region, our communities and the unique challenges many individuals face.

People First is a Company limited by guarantee which means that Trustees are guarantors rather than shareholders, so Trustees are protected from financial liability for the charity, any profit/surplus the organisation makes is reinvested into the services it delivers to support more people.

Our independence is very important to us; we are not run or controlled by any other service.

Our Head office is based in Carlisle, supported by offices across Cumberland, Lancashire and the North Fast.

Our Board of Trustees is comprised of representatives from a broad range of backgrounds, professions and disciplines; including legal, accountancy, human resources and people with lived experience of a learning disability, all working together to help us to achieve our vision and mission.

The maximum number of Trustees the Board can have at any time is 12 which comprises of Trustees from professional backgrounds and Trustees with Lived Experience of using our services.



### **Being a Trustee with us**

#### Role profile

The role of a Trustee in a growing and ambitious charity is a very important one. People First has a strong Leadership Team that manages the day-to-day business, operational activities and challenges but they can't do it alone.

We need our Board of Trustees to have a wide range of skills and experiences to help plan, think strategically and navigate challenges. The role of a trustee should demonstrate a passion for breaking new ground to lead social change.

- → Respect confidentiality
- → Promote PF whenever possible
- → Plan for the future
- → Challenge us to think differently
- → Seek assurance on quality.

Together our Board and senior staff must know where we are taking the organisation, support our staff to let their brilliance shine and try to ensure that our customers get what they need.

#### Your responsibilities

Working with fellow Trustees you will be responsible for providing advice, guidance and challenge.

The key responsibility of our trustees is to provide overall strategic leadership to the organisation and support the staff team to achieve the aims of People First.

They ensure this by attending and taking part in meetings, understanding our rules, and helping us stick to them, making decisions that are in the best interest of People First.

#### Main responsibilities include:

- Governance of the organisation
- Overseeing strategy and direction
- Monitoring performance and risk
- Ensuring inclusion of people is at the core of the organisation
- Ensure compliance with the charity's values and objectives
- Approving each year's budget, policies, business plan and accounts.

#### Remuneration and Expenses:

 Trustees are not remunerated for their time but will be reimbursed for reasonable travel and subsistence expenses occurred to attend board meetings and represent People First as required.

#### Term of Office:

- The Chair is appointed for an initial term of 2 years, renewable for a further 2 years if mutually agreeable.
- The maximum term for the chair is 6 years.

### Roles on the board

#### Chair/Deputy Chair

The Chair of the Board has overall responsibility for the operations associated with the Board of Trustees which includes the role of chairing/hosting the board meetings. The Chair of the Board is a Trustee who has the necessary skills and experience to exercise their right to a casting vote in the case a consensus of the board cannot be achieved and analysis of the organisation's best interests is needed.

The Deputy Chair of the Board works in partnership with the Board Chair to support the strategic thinking and development of the Board and organisation, as well as chairing Board meetings. The Deputy Chair however does not have the power to operate a casting vote if required and instead their vote will hold the same weighting as the votes from other Trustees. For the avoidance of doubt, the Deputy Chair shall not have the powers of the Chair to a second or casting vote at Trustee meetings

#### Trustees

Working with fellow Trustees, Trustees are responsible for providing advice, guidance and challenge.

The key responsibility of our trustees is to provide overall strategic leadership to the organisation and support the staff team to achieve the aims of People First.

They ensure this by attending and taking part in meetings, understanding our rules, and helping us stick to them, making decisions that are in the best interest of People First.

### The appointment

We are an organisation driven by the values of its people, so experience in managing a 'values - driven' organisation will be highly beneficial.

People First is an equal opportunities employer and is committed to safeguarding and promoting the welfare of children, young people and vulnerable adults and expects all staff and volunteers to share this commitment.

Applicants must be willing to undergo a DBS check and any other safeguarding checks as appropriate to the post. The appointment will be subject to the satisfactory outcome of these checks.

### How do you become a Trustee?



Individual registers interest to become a People First Trustee through a member of staff or stakeholder.



You would meet with People First's CEO and the Business Manager, to discuss the role, including the skills and experience necessary. It's also a chance for you to ask any questions you have. The meeting will conclude with you sharing with our CEO if you wish to continue with this process.



The CEO and Business Manager will meet to complete a compatibility Assessment following your meeting. This will review your skill set, relevant experience, compatibility with our existing Trustees, alignment with our values, mission and your suitability to the role based on the needs of the Board.




If the CEO deems you suitable for the Board, you'll be invited to attend 3 upcoming Board Meetings. You'll be encouraged to participate during the meetings, however you will not have any voting power associated with Trustees during these trial meetings.



After attending 3 Board Meetings, you will be asked to meet with the Chair and Co-Chair of the Board to discuss your suitability. The Chair and Co-Chair will decide if they wish to propose you to stand for election by the Board.



During the next Board Meeting, following the decision from the Chair and Co-Chair, the Board of Trustees will be asked if they wish to elect you to be a Trustee for a minimum period of 12 months. Once formally voted onto the Board you'll adhere to People First's Constitution and the Role Specification for Trustees which includes the voting power to make organisational decisions at a strategic level.


