Who we are

The Department

People First's Independent Advocacy Department hosts a range of projects focussing on supporting people to have their voices heard and their rights and choices respected.

Independent Advocacy is about working alongside people to help them:

- Explore options and choices
- Have their rights respected
- Tell people what is important to them

People First's Independent Advocacy offer provides both statutory advocacy and non-statutory advocacy all supported by our Advocacy Hub which provides information and support to enable people and their referrers to access timely advocacy. We do this through a range of projects including:

- Independent Care Act Advocacy
- Independent NHS Complaints Advocacy
- General Independent Advocacy

The Project

Health and Social Care Advocacy is an exciting new project which will actively work to improve the health and social care experiences of Refugees and Asylum Seekers living in Lancashire and Blackpool whilst challenging barriers and discrimination.

This includes:

- Advocating alongside Refugees to support them to understand their rights and choices and navigate UK health and social care systems and processes.
- Facilitating group advocacy/ awareness raising/ training sessions with Refugees to support people to feel more confident to speak up for themselves and understand the UK health and social care system.
- Working with health and social care providers to raise awareness of challenges and barriers refugees face accessing UK health and social care systems to address issues and improve outcomes.
- Developing the project and building a network of peer advocates and volunteers to increase the project reach.

This project is funded by Lancashire County Council.

- Ability to display empathy in a range of situations and deal effectively with conflict situations
- Good all round level of education including office and IT skills
- A high standard of written and verbal skills including the ability to write letters and reports
- Excellent organisational skills with the ability to manage a complex workload and to prioritise effectively
- Ability to use supervision and peer support
- Willingness to undertake training, complete the National Advocacy Qualification and other training as identified
- Excellent interpersonal skills and a team player; able to ask for and give support to colleagues, students and volunteers
- Positive attitude to a fast paced working environment where tasks and systems need to be developed and updated on a regular and ongoing basis
- Creative, flexible and enthusiastic approach
- Commitment to valuing diversity and equal opportunities
- Commitment to providing a high quality service centred on the needs of individuals who are vulnerable and disadvantaged
- Able to work occasional evenings and weekends
- Ability to be an Ambassador for People First, our projects and the people we serve

Driving

- Current driving licence and access to own transport

Desirable

- Experience of working with Asylum Seekers and/or Refugees
- A good understanding of asylum process and refugee resettlement including knowledge of rights and entitlements of asylum seekers and refugees in the UK and barriers they face in accessing mainstream services
- Understanding of complaint processes and the ability to raise concerns and challenges in a professional manner
- Knowledge of Arabic is highly desirable



Duties will include:

- Delivering one to one advocacy to support people to understand their rights and choices, explore health and social care options and make informed decisions
- Supporting people to access services; navigate health and social care systems and processes.
- Managing an active caseload ensuring timely, prioritised and responsive interventions
- Working within the appropriate legislation, People First policies and procedures, quality standards and monitoring requirements including contractual obligations, key performance indicators, QPM
- Recording accurate and appropriate data on advocacy databases
- Responding to all enquiries in a timely and courteous fashion within contractual obligations or agreed timescales
- Creating individual advocacy action plans in partnership with people highlighting what people would like support with, what they would like to achieve, how we can support them best and progress against their self-identified outcomes
- Gathering the person's wishes and feelings, as far as possible, and any values or beliefs likely to influence the decision/ process
- Obtaining, reviewing, and evaluating information including health and social care records relevant to the decision/ process
- Compiling high quality written letters and reports ensuring submission within appropriate agreed timescales
- Challenging decisions, where appropriate, using appropriate informal and formal methods including complaints procedures
- Communicating and engaging effectively with a range of people, health and social care personnel and managers, and family members
- Planning, co-ordinating and facilitating self-advocacy group/ awareness raising/ training sessions
- Keeping knowledge of local services, relevant regulations, policy, legislation, case law and good practice up to date
- Identifying any conflicts of interests and risks in delivering the service ensuring they are appropriately assessed, reported, and recorded
- Publicising, networking, and promoting all advocacy provision to the public, organisations, and key stakeholders on a local and national level
- Working as a member of the team, attending team meetings, and contributing towards service planning and advocacy developments and the wider organisation. Including facilitating continuity for both planned and unplanned leave, developing case studies, operational planning and taking a full and active part in supervision and referral reviews
- Mentoring and supervising peer advocates, volunteers, and students
- Completing all relevant Advocacy training including the independent



- advocacy qualification and other accredited training
- Prioritising, planning and coordinating project development

Other Duties

The duties outlined above are not intended to be exhaustive and may change as the needs of the organisation alter in line with current agendas

The Appointment

Applications should include:
